

**GALION CITY COUNCIL
MINUTES OF SPECIAL MEETING
March 2, 2023 at 7:30 p.m.**

The March 2, 2023 special meeting of Galion City Council was called to order by President of Council Eric Webber. The Pledge of Allegiance was followed by a moment of silence.

Clerk of Council Julie Bell called roll with the following members present: Ms. Ault, Mr. Bodkins, Ms. Durbin, Ms. Frank, Mr. Richart, and Ms. Zeger.

Ms. Durbin made the motion to excuse Dr. Fellner. Mr. Bodkins seconded. Motion carried 6-0.

The roll call for elected officials and officials required by Council Rules and the Ohio Revised Code to be present was called with the following present: Mayor O'Leary, Director of Law Palmer, and SSD Ward.

President Webber asked for a motion to add Ordinance No. 2023-22 to the agenda. Ms. Zeger made the motion which was seconded by Mr. Bodkins. The roll call on the motion results as follows: Ms. Ault, yea, Mr. Bodkins, yea, Ms. Durbin, yea, Ms. Frank, yea, Mr. Richart, yea, Ms. Zeger, yea. Motion carried 6-0.

Mr. Richart made the motion to approve the agenda as amended which was seconded by Ms. Frank. Motion carried 6-0.

Legislation

Ordinance No. 2023-22 (First Reading)

An Ordinance amending Ordinance No. 2023-20 adopting an updated consolidated fee schedule for various fees associated with the City of Galion by amending pages 11 and 12, and declaring an emergency.

Ms. Durbin made the motion to suspend the rules and proceed to the final reading on Ordinance No. 2023-22. Mr. Bodkins seconded the motion. The roll call on the motion resulted as follows: Ms. Durbin, yea, Mr. Bodkins, yea, Ms. Frank, yea, Mr. Richart, yea, Ms. Zeger, yea, Ms. Ault, yea. Motion carried 6-0

Ms. Frank made the motion to pass Ordinance No. 2023-22. Ms. Zeger seconded the motion. The roll call on Ordinance No. 2023-22 resulted as follow: Ms. Frank, yea, Ms. Zeger, yea, Ms. Ault, yea, Mr. Bodkins, yea, Ms. Durbin, yea, Mr. Richart, yea. Motion carried 6-0 and Ordinance No. 2023-22 passed for a final reading.
