ORDINANCE NO. 2021-109

ENTITLED AN ORDINANCE APPROVING THE CHANGING OF WOOD STREET AND A PORTION OF S. EAST STREET TO COVERT WAY.

WHEREAS, Covert Manufacturing started as a family owned business in 1967 and specialized in meeting the needs for specialized precision machined products; and

WHEREAS, the Covert family has continued to employ hundreds of Galionites over the last 50 years and has contributed economically and philanthropically to the Galion community; and

WHEREAS, the Galion Planning Commission has recommended the renaming of Wood Street and a portion of S. East from beginning at the intersection of Wood Street and ending at the intersection with Smith Street to Covert Way; and

WHEREAS; pursuant to ORC 723.04 a public hearing was held to determine if there is just cause for said name change and it will not be detrimental to the general interest; and

WHEREAS, Galion City Council would like to honor Donald and Rodella Covert and the entire Covert family for their extraordinary contributions.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Galion, Ohio, that:

Section 1. That the name of Wood Street be and is hereby changed to Covert Way.

Section 2. That the name of S. East Street from the intersection of the aforementioned Wood Street to the intersection with Smith Street be and is hereby changed to Covert Way.

Section 3. That this Ordinance shall be published in accordance with Ohio Revised Code Sections 731.21 and 7321.22.

Section 4. This Ordinance shall be in full force and effect on the earliest date permitted by law.
