ORDINANCE NO. 2023-56

ENTITLED AN ORDINANCE AMENDING ORDINANCE NO. 2022-98 (PERMANENT 2023 APPROPRIATIONS) BY APPROPRIATING FUNDS AND REDUCING APPROPRIATIONS IN VARIOUS FUNDS AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GALION, STATE OF OHIO:

Section 1: That Ordinance No. 2022-98 (Permanent 2023 Appropriations) passed December 28, 2022 be, and the same is hereby amended as delineated in the following sections:

Section 2: That Zero and 10/100 Dollars (\$0.10) be appropriated from unappropriated funds to 303-8010-52610 Cheshire Special Assessment Debt – Debt Service – Bonds and Notes Principal – Debt Service – Principal Retirement.

Section 3: That Five Thousand, Five Hundred and 00/100 Dollars (\$5,500.00) be appropriated from unappropriated funds to 235-2010-52326 Health Department 340B Drug Pricing Program – Public Health – General Health – Contractual Services – Advertising.

Section 4: That Ten Thousand, and 00/100 Dollars (\$10,000.00) be appropriated from unappropriated funds to 101-1020-52363 General Fund – Security of Persons & Property – Fire Department – Contractual Services – Fire Demolition Refund.

Section 5: That appropriations in 268-7090-52410 American Rescue Plan Act of 2021 - General Government – Other Government – Materials and Supplies - Operating Supplies be reduced by Seven Hundred Fifty-Nine Thousand, Six Hundred Ninety-Three and 50/100 Dollars (\$759,693.50).

Section 6: That appropriations in 268-7090-52501 American Rescue Plan Act of 2021 - General Government – Other Government – Capital Outlay - Land and Improvement be reduced by Seventy-Nine Thousand, Two Hundred Thirty-Two and 50/100 Dollars (\$79,232.50).

Section 7: That this Ordinance shall be published in accordance with applicable Ohio Law.

Section 8: That in order to preserve the public peace, health, safety and welfare of the City of Galion and its inhabitants, and in order to make the adjustments in the Permanent 2023 Ordinance No. 2023-56

appropriations without delay to meet pending obligations, this measure is determined to be an emergency Ordinance and shall take effect at the earliest time allowed by law after its passage.

WHEREAS, in accordance with O.R.C. Section 5705.41, purchase orders are to be obtained before any contract, agreement, obligation, payment or expenditure is made by any City Department, and

WHEREAS, in instances where a contract or agreement is signed or an obligation, payment, or expenditure is incurred before the purchase order is issued or when an open purchase order has been accidentally closed prematurely, a THEN AND NOW Certificate must be obtained.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GALION, OF CRAWFORD COUNTY, STATE OF OHIO:

Section 1: That the expenditure of \$60,199.38 for WTP Electricity to The City of Galion is hereby approved and such prior act without a purchase order is hereby ratified.
