

**GALION CITY COUNCIL  
MINUTES OF REGULAR MEETING  
August 9, 2022 at 7:00 p.m.**

The August 9, 2022 meeting of Galion City Council was called to order by President Pro Tempore Michael Richart. The Pledge of Allegiance was followed by an invocation from Pastor Joe Stafford from Wesley Chapel.

Clerk of Council Julie Bell called roll with the following members present: Ms. Ault, Mr. Bodkins, Ms. Durbin, Ms. Frank, Mr. Richart and Ms. Zeger.

Mr. Bodkins made the motion to excuse Dr. Thomas Fellner and Mr. Eric Webber. Ms. Durbin seconded the motion. Motion carried 6-0.

The roll call for elected officials and officials required by Council Rules and the Ohio Revised Code to be present was called with the following present: Mayor O'Leary, Auditor Saterfield, Director of Law Palmer, and Safety-Service Director Ward.

President Pro Tempore Richart asked for a motion to approve the minutes from the July 26, 2022 regular meeting. Ms. Ault made the motion to approve the minutes. Ms. Zeger seconded. Motion carried 6-0.

President Pro Tempore Richart asked to add Ordinance 2022-60 to the agenda. Ms. Ault made the motion to add Ordinance No. 2022-60 to the agenda. Ms. Zeger seconded the motion. The roll call on the motion resulted as follows: Ms. Ault, yea, Mr. Bodkins, yea, Ms. Durbin, yea, Ms. Frank, yea, Mr. Richart, yea, Ms. Zeger. Motion carried 6-0.

President Pro Tempore Richart asked to add Ordinance 2022-61 to the agenda. Ms. Zeger made the motion to add Ordinance No. 2022-61 to the agenda. Ms. Ault seconded the motion. Mr. Bodkins made the motion to approve the agenda as amended which was seconded by Ms. Zeger. Motion carried 6-0.

She was informed that the city is not yet the owner and any issues would have to be taken up with current owners / management. ### **Ordinance No. 2022-55 (Second Reading)**

An Ordinance authorizing the Safety-Service Director to purchase under the State Purchasing Program, pursuant to R.C. 125.04 (B) without competitive bidding, Aquaflex Splash Pad surfacing from Penchura for the Splash Park, and declaring an emergency.

Ms. Ault made the motion to suspend the rules and proceed to the final reading on Ordinance No. 2022-55. Ms. Zeger seconded the motion. The roll call on the motion resulted as follows: Ms. Ault, yea, Ms. Zeger, yea, Mr. Bodkins, yea, Ms. Durbin, yea, Ms. Frank, yea, Mr. Richart, yea. Motion carried 6-0.

An Ordinance authorizing and directing the Safety-Service Director execute a Housing Revolving Loan Fund Administration Agreement with the Ohio Department of Development, and declaring an emergency.

Ms. Ault made the motion to suspend the rules and proceed to the final reading on Ordinance No. 2022-60. Ms. Zeger seconded the motion. An Ordinance authorizing the Safety-Service Director to advertise for bids and to enter into a contract with the lowest and best bidder therefor, as provided by law, for the Phase I Water Treatment Plant Improvement Project, to proceed, authorizing payment therefor, and declaring an emergency.

Ms. Ault made the motion to suspend the rules and proceed to the final reading on Ordinance No. 2022-62. Ms. Frank seconded the motion. The roll call on the motion resulted as follows: Ms. Ault, yea, Ms. Frank, yea, Mr. Richart, yea, Ms. Zeger, yea, Mr. Bodkins, yea, Ms. Durbin, yea. Motion carried 6-0.

Ms. Zeger made the motion to pass Ordinance No. 2022-62. Ms. Ault seconded the motion. An Ordinance amending Section 3 of Ordinance No. 2022-4 which amended Ordinance No. 2021-114 (Permanent 2022 Appropriations) by advancing and transferring funds in various funds and declaring an emergency.

Ms. Zeger made the motion to suspend the rules and proceed to the final reading on Ordinance No. 2022-64. Ms. Ault seconded the motion. Council resumed regular session at 9:00 p.m.
